2. Formulation (ऊँ) is of transcendental code value 16.

3. Formulation (इति) is of transcendental code value (8)

Formulation (एक)
4. Formulation (एक) is of transcendental code value (8). Formulation (अक्षर)
5. Formulation (अक्षर) is of transcendental code value (13) Formulation (ब्रह्म)
6. Formulation (ब्रह्म) is of transcendental code value (28).
7. One may have a pause here and take note that values range $(16,8,8,13,28)$ of summation value $(16+8+8+13+28=65)$ $=5 \times 13$.
8. Value 65 is parallel to summation value of transcendental range $(11,12,13,14,15)$ of hyper cube 13 of origin value 14 and base value (15).

## VALUE 16

9. Value 16 is parallel to TCV value 16 of formulation (द्वय), of simple rendering as value (2).
10. Further, $2=1+1$ bring us face to face with $16=8+8$, parallel to the format of:
TCV (द्वय) $=$ TCV (एक) + (एक).
11. Still further, values range 1 to 16 leads to 29 factors.
12. One may have a pause here and take note that $29=16+13$.
13. Further, value 29 is parallel to TCV (ब्रह्मा).
14. One may have a pause here and take note that values pair (16, 13) accepts organization as $(5+6+5),(4+5+4)$ which is parallel to transcendence spectrum of transcendence of 6space as origin out of 5 -space domain, and transcendence of 5 -space origin out of 4 -space domain.
15. One shall sit comfortably and to permit the transcending mind to glimpse and imbibe these values and features.

## FORMULATION PAIR

16. Formulation pair (ब्रह्मा, ब्रह्मा) leads to TCV values pair (29, 28).
17. One may have a pause here and take note that 29 points range give rise to 28 gaps.
18. One shall sit comfortably and to glimpse and imbibe these values and features.

## FORMULATION (निर्देश)

19. Formulation (निर्देश) is of transcendental code value 27.
20. One may have a pause here and take note that 28 points range leads to 27 gaps.
21. One shall sit comfortably and to permit the transcending mind to continuously remain in prolonged sitting of trans and to glimpse and imbibe these values and features.
22. It will be blissful to take note that values range (1 to 28 ) leads to $2^{27}$ frequencies for reach at value 28 by choices from the values range 1 to 28 .
23. One shall permit the transcending mind to glimpse and imbibe these values and features.
24. It will be blissful to be face to face with value $2^{27}=$ 13,42,17,728.
25. It would be very blissful to further glimpse the internal organization of value (28).
26. Value range ( 1 to 28 ) leads to (56) factors.

30. It will be blissful to take note that $83=81+2=3^{4}+2$, which is parallel to the domain of dimensional value $3^{4}$ within creator's space / 4 -space with 5 -space as its origin.
31. One shall sit comfortably and to permit the transcending mind to continuously remain in prolonged sitting of trans and to glimpse and imbibe these values and features.
32. Further product of all proper divisors (1, 2, 4, 7, 14) of (28) is $1 \times 2 \times 4 \times 7 \times 14=784$, which as dimension structure ' 786 ' as domain.
