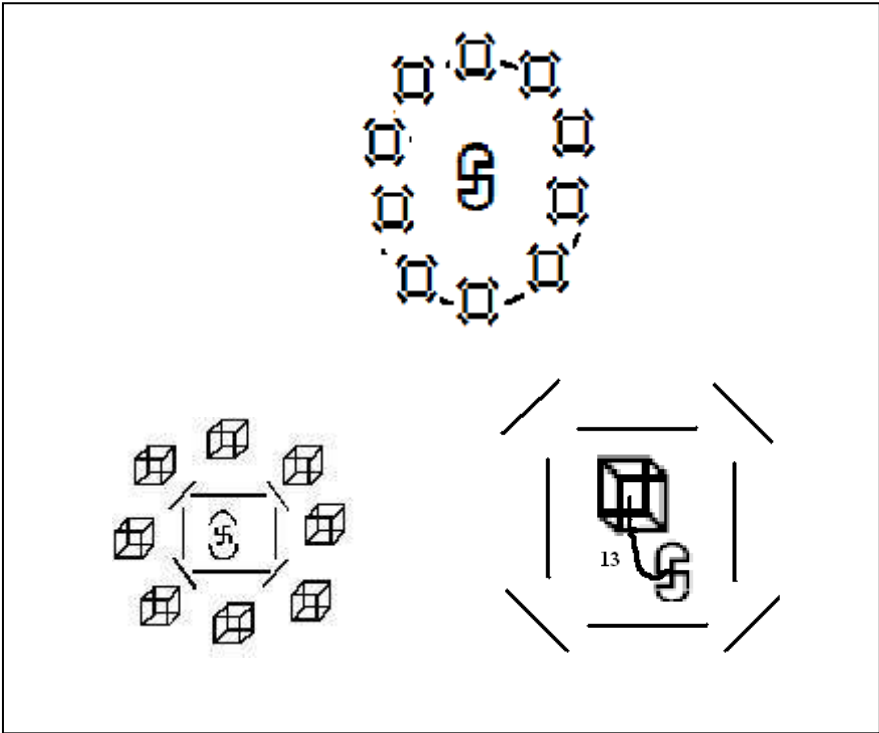

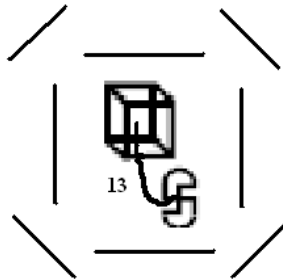

TRANSCENDENTAL BASE



1. Transcendental base of manifested creation is the fifth fold of four folds manifestation layers.
2. Within creator's space (4-space), manifestations along format of idol of Lord Brahma are four folds manifestation layers of dimensional fold, boundary fold, domain fold and origin fold.

3. Creator's space (4-space) is of transcendental origin (5-space as origin).
4. 5-space plays the role of transcendental origin of 4-space.
5. 5-space plays the role of transcendental base, as fifth fold of four folds manifestation layers.
6. One may have a pause here and take note that 4-space plays the role of creative boundary of the transcendental domain (5-space domain).
7. Creator's space is of a spatial dimensional order while transcendental domain is of a solid dimensional order.
8. Within creator's space, solids have a degree of freedom of motion which manifests as 13th edge of 12 edge cube.
9. This 13th edge leads to and connects with the seat of transcendental origin of creator's space.

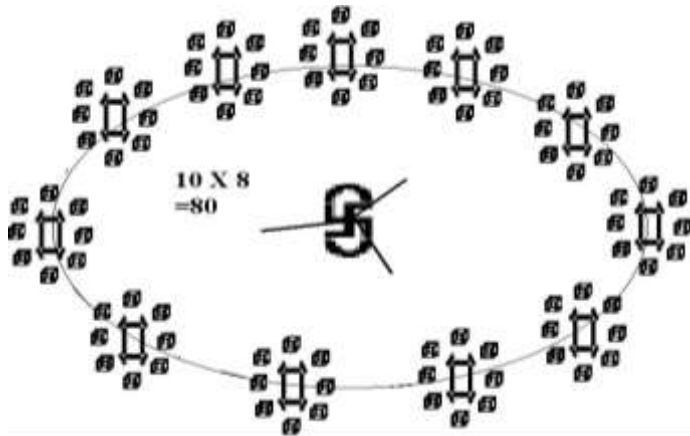


10. One may have a pause here and take note that 4-space is a spatial order space, and as such the 13th edge manifestation format is going to be of spatial format.
11. One shall glimpse and imbibe the above features and roles of 2-space content, 3-space content, 4-space content and 5-space content as spatial dimensional order of 4-space, solid

boundary of 3-space, creative domain of 4-space and transcendental origin of 4-space, together as four folds manifestation layer.

12. One may further have a pause here and take note that this simultaneous manifestation feature of 2-space content, 3-space content, 4-space content and 5-space content brings us face to face with the manifestation feature of manifestation phenomenon as of value $2+3+4+5 = 14$ and hyper cube 14 as four folds manifestation layer (12, 13, 14, 15) leads us to value $12+13+14+15 = 54$ which accepts organization as $54 = 14+40$ with value $14 = 2+3+4+5$, parallel to four folds manifestation layer (2, 3, 4, 5) of hyper cube 4 and $40 = 4 \times 10$ parallel to 40 coordinates fixation of creative boundary of ten Components of transcendental domain.
13. It would be blissful to take note that $54 = 27+27 = 3^3 + 3^3$ which is parallel to the set up of 27 nakshatras of northern hemisphere together with 27 nakshatras of southern hemisphere.
14. Further, hyper cube 14 is of $2 \times 14 + 1 = 29$ versions.
15. Still further, formulation Brahma accepts transcendental code value 29.
16. One shall sit comfortably and to permit the transcending mind to glimpse and imbibe format feature of idol of lord Brahma, being parallel to the format and features of hyper cube 4.
17. It would further be very blissful to permit the transcending mind to chase the way, with the grace of transcendental lord Shiv, lord Brahma multiplies as ten Brahmas within

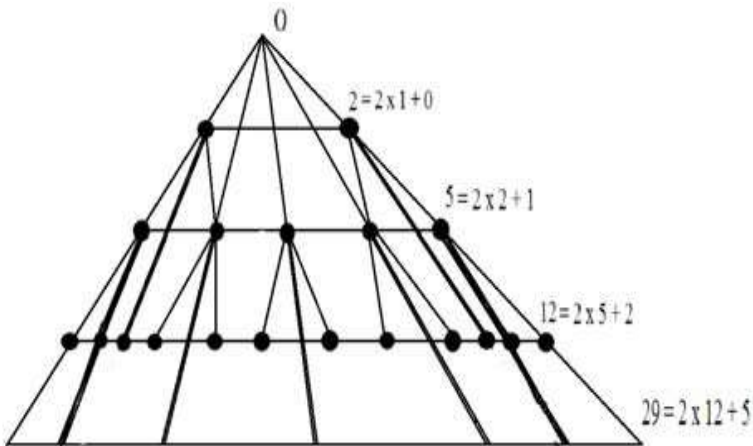
transcendental domain and is of potential and virtues of creative boundary of ten Components of transcendental domain.

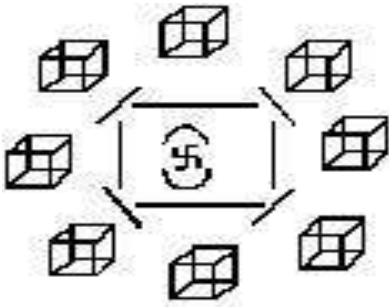


18. Sadhakas fulfilled with intensity of urge to glimpse and imbibe the values and features of transcendental based of

ashtadhiya shall sit comfortably and to permit the transcending mind to glimpse and imbibe the above values and features of quadruple space contents of 2, 3, 4, 5-spaces simultaneously manifesting as a four folds manifestation layer (2, 3, 4, 5) with the potentialities and features of re-manifestation as hyper cube 14 being a four folds manifestation layer (12, 13, 14, 15) with transcendental base fold being of value (16).

19. It would be blissful to visit and revisit five folds transcendence range (12, 13, 14, 15, 16) of summation value $12+13+14+15+16 = 70$.
20. One may have a pause here and take note that domain split spectrum is of sequential progression value (1, 2, 5, 12, 29, 70, ...).





21. It would be a very blissful exercise to visit and revisit the format feature of hyper cube 4, idol of lord Brahma and domain split spectrum flow, which permit depiction and expression.



22. It would further be very blissful to take note that transcendence of solid order from the transcendental base of creator space shall be making the set up of 4 folds manifestation layer (2, 3, 4, 5) of summation value $2+3+4+5 = 14$ as of value $14 \times 3 = 42$, which accepts organization $(2+3+4+5+6)+(2)+(2+3+4+5+6)$ which is parallel to synthesis value of a pair of transcendence range of spatial order.

23. It is this feature which deserves to be comprehended well for its full appreciation for acquiring proper insight and for

attaining appropriate enlightenment of the organization
format of 14 Maheshwara sutras and 42 Pritiyaharas.

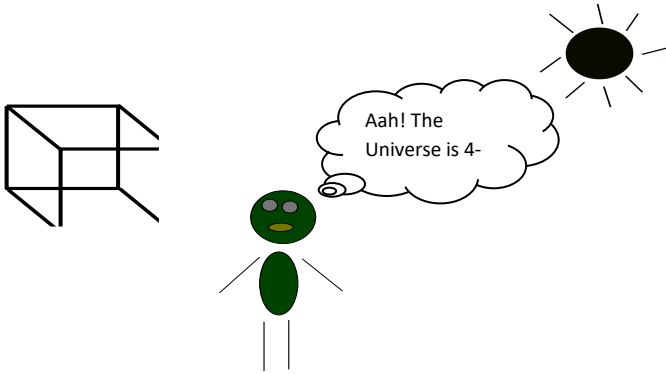


1. Sadhakas fulfilled with intensity of urge to acquire insight to attain enlightenment about vedic systems values and virtues shall urge to know the way mental states manifests and un-manifest.
2. The physical (3-space content) manifests 3-space domain and the same manifests a mental state of a linear order.
3. While one sits within a room and starts accepting the set up for the entire space existence phenomenon as of a 3-space set up, the same is because of the linear order of 3-space content which has its reach uptill the spatial boundary of 3-space domain / walls, floor and roof of the room / spatial boundary of cube / hyper cube 3.

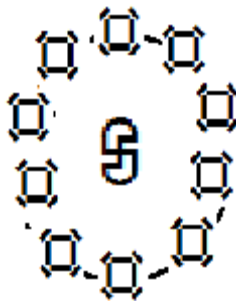


4. One may have a pause here and take note that while one comes out of a room (cube / hyper cube 3), the linear order mental state melts away and one transits from the mental state of 3-space content and mental state of 3-space melts away and same transits and re-manifest as of 4-space content

(of the spatial order of creator's space / 4-space / domain fold of hyper cube 4.



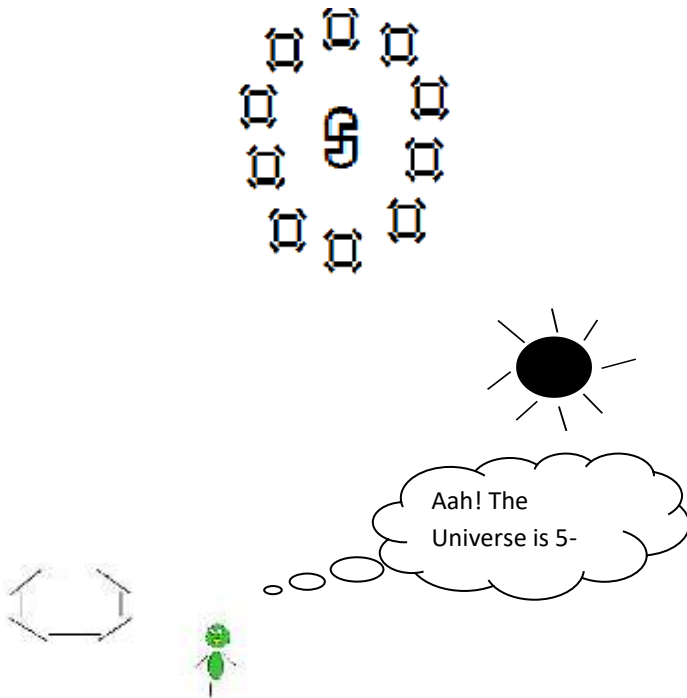
5. One may have a pause here and take note that spatial order mental state, as it is the same is because of the solid boundary of hyper cube 4.



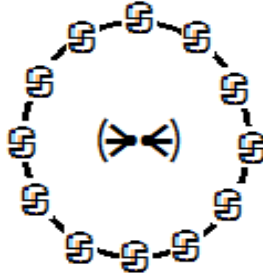
6. One may have a pause here and take note that to permit the transcending mind to glimpse and imbibe the way spatial

order mental state melts away and re-manifest as a transcendental mental state of a solid order.

7. It is going to be a transition and transformation with melting away of the solid boundary of creator's space and the same re-manifesting as a set up of transcendental content (5-space content manifesting as transcendental domain (5-space domain of hyper cube 5 enveloped with in creative boundary of ten Components



8. A step ahead, one shall permit the transcending mind to continuously remain in prolonged sitting of trans to melt away the creative boundary itself and to attain self referral mental state of the order of pursha / Sun / Vishnu Lok / 6-space self referral content manifesting as 6-space domain enveloped within transcendental boundary of 12 Components.



9. One may have a pause here and take note that initial linear order mental state of 3-space content (physical matter) is a mundane state / sathual Shreer manifestation / first consciousness state / jagrit avashta.
10. The spatial order mental state is manifestation of suksham shreer of swapan avashta.
11. Solid order mental state of karan shreer is the reach of sushapti avashta.
12. Creative order mental state is of karan attiet turiya avashta.
13. Beyond that is transcendental order state of truiya attiet avashta. It is unity state of existence phenomenon.

14. A step ahead, is a mental state of transcendental order set up of asht prakarti.
15. And a step ahead, is unity state order of nav Braham.
16. Even beyond that Brahman order of par Braham existence phenomenon.
17. Sadhakas fulfilled with intensity of urge to glimpse and imbibe these values and these mental states of such reach shall continuously permit the transcending mind to remain in prolonged trans and to sequentially glimpse and imbibe virtues of these values of sequential progression path of manifestation, melting of manifestation and re-manifestation process of our existence phenomenon within human frame.
18. Further, sadhakas fulfilled with intensity of urge to simultaneously follow the sankhya and yoga nishta shall also be face to face with the way sequential progression un-fold.

‘Illustrative:

As first step, one may glimpse the start with value.

As second step, one shall glimpse the next step value in relation with the first step value. Here it may not be a single value, and the same may be a pair, triple, quadruple or even bigger range of values association for the second step.

And then, in third step, one shall reach at a progression rule for the subsequent steps value that is in respect of third, fourth, fifth and subsequent step value.

19. Here, illustratively one may accept first step value ‘1’. And next step value to be ‘2’. Then one shall pause for reach at a rule for 3rd and following step value for such sequential progression reach (1, 2, ?, ?, ...).

20. One answer lead will be $(1, 1+1, 1+1+1, 1+1+1+1, \dots)$.
21. The other answer lead may be $(1, 2 \times 1, 2 \times 2 \times 1, 2 \times 2 \times 2 \times 1, \dots)$.
22. Another illustration is, as that the first step value (1) and second step value (3) will pause the similar situation of sequential progression values rule need.
23. One lead may be as $(1, 1+2 = 3, 2+3 = 5, 2+5 = 7, \dots)$.
24. The other lead would be $(1, 1+2, 1+2+3, 1+2+3+4, \dots)$.
25. Like that, reach from (a, b) would be of many fold progression expression:
(a, b, c, ...) where c may admit various different values.

TRANSCENDENTAL DOMAIN

TRANSCENDENTAL BASE OF ASHTADHEY

1. Ashtadhey is organized as eight chapters of four sections each.
2. This feature, as is of value 32 (8×4), accepts re-organization as $32 = 2^5$, which is parallel to frequency of value '6' of choices from values range (1, 2, 3, 4, 5, 6).
3. Value 32 is also parallel to the range of 32 external Devtas.
4. Further, hyper cube 4 with domain boundary ratio $A^4:8 B^3$ lead to fixation of solid boundary of 8 components in terms of $8 \times 4 = 32$ coordinates in spatial dimensional frame of quadruple dimensions of creator's space within 4-space.
5. Further $32 = 14 + 18$
6. Value 14 accepts re-organization as $14 = 2 + 3 + 4 + 5$, which is parallel to four fold manifestation layer (2, 3, 4, 5) of hyper cube 4.

7. Likewise $18 = 3 + 4 + 5 + 6$ is parallel to four fold manifestation layer (3, 4, 5, 6) of hyper cube 5 the representative regular body of 5-space within 4-space.
8. One may have a pause here and take note that 5-space plays the role of origin of 4-space.
9. 5-space is origin fold of hyper cube 4 and is also of the role of 5-space as domain fold of hyper cube 5.
10. One may further have a pause here and take note that 5-space plays the role of base fold of transcendence range (1, 2, 3, 4, 5)
11. With 5-space as base of 4-space origin of 3-space, brings us face to face with organization format features of transcendental base of four fold creation of linear order set ups of hyper cube format for cube as hyper cube 3.
12. It is this feature which deserve to be comprehended well for its complete appreciation and full imbibing to acquire proper insight and to attain appropriate enlightenment about the role of transcendent base (5-space).
13. It would be blissful to take note that transcendental base (5-space) as base fold is of solid dimensional order..
14. One may have a pause here and take note that 3-space plays the role of boundary of 4-space.
15. Further 3-space content manifest as domain fold of hyper cube 3.
16. Still further 3-space plays the role of solid dimensional order 5-space base fold
17. Still further 3-space plays the role of origin of 2-space which is also having the role of spatial dimensional order of 4-space.

18. One may have a pause here and to permit the transcending mind to glimpse and imbibe the interrelated values of different roles of 2, 3, 4, 5 in their respective role in their boundary, domain, origin and base fold.
19. It would be blissful to glimpse following 5 x 5 format to have comprehensive view of interrelated roles of 1 to 9 space

20. It would be a blissful exercise to chase the interrelationship of 2-space with 5-space 3-space with 5-space and 4-space with 5-space.



ARTIFICES OF NUMBERS AND DIMENSIONAL FRAMES

1. Sadhakas fulfilled with intensity of urge to acquire proper insight and to attain Appropriate enlightenment about Vedic processing systems shall sit comfortably and to permit the mind to be face to face with parallel values and features and formats of artifices of numbers and dimensional frames.
2. One shall visit and revisit artifices of numbers 1 to 9 and dimensional frames of 1-space to 9-space.
3. Hyper cubes 1 to 9 are the representative regular body of 1-space to 9-space within creator's space (4-space).
4. Space content of 1-space to 9-space manifests as domain fold of respective hyper cubes.
5. Our well known body (cube) is hyper cube 3, the volume part of cube is its domain fold.
6. One may have a pause here and take note that cube / hyper cube 3 is a 4 folds manifestation layer: (1-space in the role of dimension, 2-space in the role of boundary, 3-space in the role of domain, 4-space in the role of origin).
7. For convenient reference here below is depiction and expression along 4x4 grid format of different roles to be played by a given dimensional space:

11. One may have a pause here and take note that hyper cube 9 is of $2 \times 9 + 1 = 19$ versions parallel to 19 geometries range of 9-space.
12. It would further be blissful to take note that $100 = 81 + 19$.
13. One shall sit comfortably and to permit the transcending mind to glimpse and imbibe these values and features.
14. It would further be blissful to take note that 9×9 grids accommodate values range 1 to 17.
15. It would further be very blissful to take note that values pair (19, 17) is parallel to the format of (19 as domain, 17 as dimension).
16. It would further be very-very blissful to take note that formulation Aatma accepts transcendental code value 17 which is parallel to 17 versions of hyper cube 8 parallel to 17 geometries of 8-space.
17. One may have a pause here and take note that the alphabet letters of devnagri alphabet accepts transcendental code value of range 1 to 16.
18. Further as that, value 16 accepts organization as $16 = 9 + 7$ and pair of values 9, 7 is of format parallel to (9-space domain, 7-space dimension).
19. It would be blissful to take note that formulation Jeev accepts transcendental code value 16.
20. Still further, $9 + 9 = 18$ is parallel to transcendental code value 18 of formulation Vidhi.
21. It would be very blissful to take note that formulation Vidhya, as well as formulations Prakarti and Ishwar as well accepts transcendental code value 18 each.

22. Still further as that, value 18 accepts organization as $18 = 3+4+5+6$, which is parallel to 4 folds manifestation layer (3, 4, 5, 6) of hyper cube 5, the representative regular body of 5-space with 4-space along the format of idol of lord Braham, over lord of creator's space (4-space).
23. Still further, it would be very blissful to take note that quadruple (3, 4, 5, 6) is parallel to organization format of right angled triangle (3, 4, 5) of area (6).
24. Still further, the feature $3^2+4^2=5^2$ bring us face to face with value $3^2+4^2+5^2 = 50$ which is parallel to 50 letters set up of devnagri alphabet of 9 vowels, 33 consonants and 8 yama letters.

 - (xi) Turyia (तुरीया) accepting transcendental code value 16 and formulation Sodash (षोडश) accepting transcendental code value 26.
 - (xii) Value 26 with organization $26 = 19+7$, being parallel to transcendental code value $19+7$ of formulation Savita Kariya (सविता कार्य) of Suksham (सूक्ष्म).

- (xiii) A reach from Sthul (स्थूल) (TCV 20) to Suksham (सूक्ष्म) (TCV 26) is the reach step on Vedic format to Brahman.
55. Formulation Ved (वेद) is of transcendental code value (20).
56. Formulation Brahman is of transcendental code value 37 which is parallel to 37 geometries range of 18-space and there are 37 versions of hyper cube 18, the representative regular body of 18-space.
57. One shall sit comfortably and to permit the transcending mind to glimpse and imbibe the format of values pair (18, 20) parallel to 18-space as dimension, 20-space as domain.
58. It will be blissful to permit the transcending mind to glimpse and imbibe transcendental code value 18 of formulation Ishwar (ईश्वर) and transcendental code value 37 as transcendental code value of formulation Sri Bhagwan.

1. Vedic Mathematics format is of features and values settling the organization format of Vedas.
2. Following 32 scripture will help acquire proper insight and to attain appropriate enlightenment about Vedic Mathematics format.

3. In addition the Vedic literature (scripture accepting Vedas as source) also will lead to dipper insight about the features and values basis of Vedic Mathematics.
4. One shall sit comfortably and to permit the transcending mind to glimpse and imbibe these values and features and one shall be faced to face with spatial order creator's space with transcendental origin manifesting Vedic Mathematics format.
5. Spatial order itself of zero order and with it Vedic Mathematics format leads to 0-space in the role of dimension of dimension of creator's space (4-space) with transcendental origin (5-space of solid order as origin of creator's space of spatial order).

FORMAT OF MODERN MATHEMATICS

6. Format of modern mathematics is of values and features at the base of the mathematical problems raised and answered during 20th century and continued to be ranged and answered accepting the same values and features.
7. One shall sit comfortably and to permit the transcending mind to glimpse and imbibe these features by being face to face with Hilbert's enlistment of problems in 1900.
8. The problems solved since 1995, the year of proof of Fermat's last theorem, till proof of pentagonal tiling (in 2015),

and till date will help us comprehend as that it is all about taming of surface curve.

9. Modern mind is struggling tame surface curve and is at every step getting blocked with the linearity order and transition there from and transformation in the form of spatial order is eluding comprehensive acceptance on the part of modern mathematical mind is there not only because of the Axioms and postulate but also is because of repulsive response of transcendence at the origin and consciously compatification of whole range of origins of higher dimensional spaces.

0-ORDER OF SPATIAL SPACE

10. Conceptually Vedic systems work with basic constituent of structure being Bindu, a structure point.
11. Word formulation Bindu is of transcendental code value '26'.
12. Value 26 accepts re-organization as $26 = 5+6+7+8$, which is parallel to hyper cube 7, representative regular body of 7-space unity space of transcendental order (5-space in the role of 7-space).
13. One may have a pause here and take note that the operation $[\{(N+(N+2)) + \{N \times (N+2)\} + \{2(N+2)+1\})]$ for odd values of N accept organization as $(M+(M+1)+(M+2)+(M+3))$ parallel to four folds manifestation layers (M, M+1, M+2, M+3) of hyper cube (M+2) with $M = N+4$.
14. One may have a pause here and take note that (N, N+2, N+4) as such is the format of N-space as dimension of (N+2-space and (N+2-space) being dimension of N+4-space.

15. One may further have a pause here and take that this amounts shift from dimension of dimension (N-space) to (N+4) domain.
16. It would be blissful to revisit above for $N = 3$.
17. $(3+5)+(3 \times 5)+(2 \times 5+1) = 34$.
18. Value 34 accepts organization as $34 = 7+8+9+10$, parallel to four folds manifestation layer (7, 8, 9, 10) of hyper cube 9 with 7-space in the role of dimension of 9-space.
19. One shall have a pause here and to permit the transcending mind to glimpse and imbibe the above reach of Vedic mathematics.

20. Vedic Mathematics comprehension and imbibing of the features and values of the format of 0-space in the role of

dimension of 2-space has helped to reach at dimensional synthesis values for whole range of dimensional spaces for every number of dimension of same order, being of following tabulation:

MELTING OF MENTAL STATE

21. Modern mathematical mind is of linear order while Vedic mathematical mind is of spatial order mind, as such transition and transformation and for parallel chase format there is a need for melting of mental state of linear order for transition and transformation into as of mental state of spatial order.
22. With this transition and transformation the whole chase would shift from the space within a three dimensional frame of 3 linear dimension into a space within a dimensional frame of quadruple spatial dimension.
23. Sequentially, the transition would proceed ahead, firstly from space within a three dimensional frame of 3 linear dimensions into space within a dimensional frame of quadruple spatial dimensions, and at next step into a space within dimensional frame of Penta solid dimensions.
24. One shall sit comfortably and to permit the transcending mind to glimpse and imbibe these values and features of Vedic Mathematics format vis-à-vis format of modern mathematics.



VEDIC MATHEMATICS FORMAT AND FORMAT OF MODERN MATHEMATICS

1. Sadhakas fulfilled with intensity of urge to glimpse and imbibe the values and features of chase format of Vedic Mathematics shall sit comfortably and to permit the transcending mind to glimpse and imbibe word formulation (बिन्दु सरोवर) (BINDU SAROVAR).
2. Formulation (बिन्दु) Bindu is of transcendental code value '26'.
3. Formulation (बिन्दु) Bindu is a composition of pair of syllables (i) (बि) TCV 9), and (ii) (न्दु) TCV 17).
4. One may have a pause here and take note that value 26 with organization $26 = 9+17 = 9+8+9$, with its reversal orientations (-9, -8, -9) brings us face to face with the organization of (-9-space domain) with origin (-8-space) leads to origin transcendence spectrum (-9, -8, -9).
5. One may have a pause here and take note that formulation (बि) is of transcendental code value 9 with organization $9 = 7+2$ and formulation (दु) as well is of transcendental code value 9 but of organization $9 = 6+3$.
6. One may further have a pause here and take note that composition of formulation (बि) = $9 = 7+2$ is parallel to the

format of divya ganga flow from first Component (बिन्दु सरोवर) (BINDU SAROVAR) of sole syllable Om, as seven streams reaching uptill second Component (अर्धमात्रा) Ardh Matra.

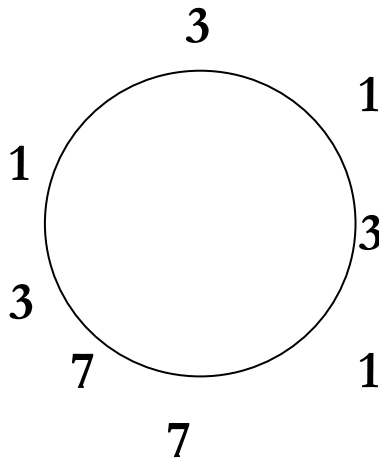
7. Further, formulation (३) of TCV value 9 of organization $9 = 6+3$ is parallel to the format of split of seven streams as a pair of 3 streams towards east and 3 streams towards west and the central streams proceeding ahead for its reach within the pushpika.
8. One may have a pause here and take note that above split is parallel to a split of a three dimensional frames into a pair of three dimensional frames of half dimensions of opposite orientations.
9. One may further have a pause here and take note that devnagri script of values pairs (३, ६) is of opposite orientation.
10. This feature deserves to be comprehended well for its complete comprehension and full appreciation as parallel to it is the composition of organization of formulation (३) of transcendental code value 9 with organization $9 = 6+3$.
11. One may further have a pause here and take note that the central stream as of its reach with in pushpika, further brings us face to face with word formulation (एक) of transcendental code value (8) parallel to TCV (८) = 8.
12. One may have a pause here and take note that pushpika is of the format of hyper cube 4, the representative regular body of

- 4-space as four space domain enveloped within solid boundary of 8 Components.
13. One may further have a pause here and take note that 4-space is of transcendental origin (5-space as origin) and that 5-space is of a solid order and this as such brings us face to face with the reach of central stream within pushpika making a set up of transcendental domain superimposed with solid order, as a set up and composition $8 = 5+3$.
 14. One shall sit comfortably and to permit the transcending mind to continuously remain in prolonged sitting of trans and to glimpse and imbibe these features and values of composition organization of word formulation (बिन्दु).
 15. Vedic systems approach structure of (बिन्दु) as (सरोवर) / Sarovar / Reservoir.
 16. One may have a pause here and take note that word formulations (बिन्दु) as well as (सरोवर) both accepts transcendental code value 26 each.
 17. Word formulation (सरोवर) is a composition of quadruple syllables (i) (स) of transcendental code value 4, (ii) (रो) of transcendental code value '10', (iii) (व) of transcendental code value '8', (iv) (र) of transcendental code value '4'.
 18. The first syllable (स) of transcendental code value 4 is of organization $4 = 3+1$.
 19. One may have a pause here and take note that values pair (3, 1) is of the format of 3-space domain with 1-space in the role of dimension.

20. Second syllable (रो) is of transcendental code value $10 = 3+7$.
21. One may have a pause here and take note that values pair (3, 7) is parallel to 3-space being of 7 geometries range and parallel to it cube / hyper cube 3 is of 7 versions parallel to representative regular body of 7 geometries of 3-space.
22. Third syllable () is of transcendental code value $8 = 7+1$.
23. One may have a pause here and take note that values pair (7, 1) is parallel to the reach of linear order (1-space in the role of dimension) is uptill 7 progressive steps only.
24. One may have a pause here and take note that hyper circles 1 to 7 increase and from hyper circle 8 onwards there is decrease and this as such makes the reach uptill hyper circle 7 as the upper limit of the linear order reach.
25. Fourth syllable (र) as well is of transcendental code value $4 = 3+1$.
26. One may have a pause here and take note that first and fourth syllables are of transcendental code value four each.
27. The reach from first syllable to the second syllable is reach from value (4 to value 10).
28. One may have a pause here and take note that value pairs (4, 10), is of the format of a reach for 4-space domain uptill creative boundary of ten Components of transcendental domain (4-space as boundary of 10 Component of 5-space domain).
29. Further values pair (4, 10) brings us face to face with $4 = 1+1+1+1$ and $10 = 1+2+3+4$, a pair of affine equal values

- progression (1, 1, 1, 1) and sequential values progression (1, 2, 3, 4).
30. The reach from 4th syllable to 3rd syllable is a reach of values pair (4, 8).
 31. One may have a pause here and take note that values pair (4, 8) is parallel to the format of 4-space domain accepting solid boundary of 8 Components.
 32. Further, 4-space plays the role of origin of 3-space and because of spatial order of 4-space, 3-space splits into eight octants and parallel to it there happens to be a split of cube into sub cubes.
 33. Further, this leads to the internal organization of the volume of cube in-terms of its four internal diagonal coordinating all the eight corner points of the cube.
 34. It further, bring face to face with the set up of 3 dimensional frames of half dimensions imbedded in each of the 8 corner points of the cube.
 35. One shall sit comfortably and to permit the transcending mind to glimpse and imbibe these values and features of composition of formulation (सरोवर) of TCV values range (3, 1, 3, 7, 7, 1, 3, 1).
 36. Inward progression from both ends, as such, here of this range is of opposite orientation as much as that the pair of initial step from one end are of values pair (3, 1) while the same from the other end is of values pair (1, 3).
 37. A step ahead, the progression from the first end is of values triple (3, 1, 7) while from the other end is of values triple (1, 3, 1).

38. One shall sit comfortably and to permit the transcending mind to continuously remain in prolonged sitting of trans and to glimpse and imbibe the values and features of progression format from the first end beginning with value 3 and sequentially reach at values (3, 1), (3, 1, 7), (3, 1, 7, 7).
39. Then, to chase inward progression from the other end as of values steps (1), (1, 3), (1, 3, 3), (1, 3, 1, 7).
40. It would further be a blissful exercise to chase above organization format as of quadruple syllable transcendental code values (4, 10, 8, 4) by plotting them along the circumference for having insight about the internal organization of the syllables themselves:



41. One may have a pause here and take note that at fourth step form either ends the reach is at value (7).

42. Pair of values (7, 7) as middle value (14), deserves to be revisited in the light word formulation (Sapt) (सप्त) which is of simple rendering as value (7) while it is of transcendental code value (14).
43. A step ahead, from the middle values pair (7, 7) will sequentially lead us to triple values pairs (3, 1), (1, 3) and (3, 1).
44. One may have a pause here and take note that triple pairs (3, 1), (1, 3), (3, 1) brings us face to face with the double reflection pairing organization, with first phase as of a reach (3, 1) to (1, 3) and at second phase the reach being from (1, 3) to (3, 1), the original position.
45. One shall sit comfortably and to permit the transcending mind to continuously remain in prolonged sitting of trans and fully glimpse above organization feature and values of composition organization format of formulation (सरोवर)..
46. Further one shall revisit quadruple pairs values features:
(i) (7, 7), (ii) 3, 1, (iii) 1, 3, (iv) 3, 1,
47. For their composite value quadruple (14, 4, 4, 4), and also for their first digits (7, 3, 1, 7) and (7, 1, 3, 1).
48. Still further, the chase also shall be for both orientations:
(14, 4, 4, 4) and for (4, 4, 4, 14).
49. Further, as the linear order structure 3-space domain, and a head 4-space domain becomes a domain of spatial order, and as such (4, 4, 4, as first three steps, and (14) being the fourth step, will help us comprehend and to appreciate the re-organization of value $14 = 2+3+4+5$ which is parallel to four

- folds manifestation layer 2, 3, 4, 5 of hyper cube 4, the representative regular body of spatial order 4-space.
50. Further as that $2+2 = 4 = 2 \times 2 = (-2) \times (-2)$ as such not only the addition and multiplication operation get superimposed in distinguishably but also same become the fait of pair of opposite orientation as well..
 51. One may have a pause here and take note that it is because of these features that while linear order mathematics of 3-space permit working in terms of '1' as 1 but the spatial order of 4-space permits working, firstly as '2 as 1 and secondly (1 as 2.
 52. One shall sit comfortably and to permit the transcending mind to continuously remain in prolonged sitting of trans and to glimpse formulation (Sapt), firstly for its simple rending value 7 and then also for its transcendental code value (14).
 53. Sadhakas fulfilled with intensity of urge to fully glimpse and completely imbibe the working steps of Vedic Mathematics of spatial order shall permit the transcending mind to glimpse and imbibe the transcendental origin (5-space as origin) of solid order of spatial order creative space (4-space) with 2-space as dimension.
 54. Creator's space (4-space) being of spatial order, same permits progression along a pair of streams, and likewise the transcendental space (5-space) because of its solid order permit progression as triple streams.
 55. One shall permit the transcending mind to glimpse and imbibe the following progression, at the fifth step for four folds manifestation layers (2, 3, 4, 5) of summation value 14.

- (i) (2, 3, 4, 5) of reach (2, 3, 4, 5, 6) as a linear progression.

58. Still further, [$\{2, 3, 4, 5\}$, (2, 3, 4, 5), (2, 3, 4, 5)] is of summation value $42 = 14+28$.
59. One may have a pause here and take note that value (6) is the first perfect number value.
60. Further value 28 is the second perfect number value.
61. Value 6 is of 3 proper divisors, while value 28 is of 5 proper divisors and values pair (3, 5) is of format of 3-space as dimension and 5-space as domain.
62. It will be blissful to take note that value 20 is parallel to transcendental code value of formulation (वेद), as well of (देव).
63. And, value 19 is parallel to transcendental code value 19 of formulation (सविता) as well as of (कृष्ण)
64. And, value 42 is parallel to transcendental code value 42 of formulation (तत्त्वज्ञान).
65. Vedic systems reach is the reach of (क्षेत्रं क्षेत्रज्ञ तत्त्वज्ञान), the essence of values and virtues of existence phenomenon.
66. It would be blissful exercise to fully glimpse and imbibe the values and features of formulations (क्षेत्रं क्षेत्रज्ञ तत्त्वज्ञान).

67. Formulation (क्षेत्रं) is of transcendental code value 20 which is parallel to synthesis value of a pair of transcendence range of zero order: $(0+1+2+3+4)+(0)+(0+1+2+3+4) = 20$.
68. Formulation (क्षेत्रज्ञ) is of transcendental code value 31, which is parallel to synthesis value of a pair of transcendence range of linear order $(1+2+3+4+5)+(1)+(1+2+3+4+5) = 31$.
69. Formulation (तत्त्वज्ञान) is of transcendental code value 42 which is parallel to synthesis value of a pair of transcendence ranges of spatial order: $(2+3+4+5+6)+(2)+(2+3+4+5+6) = 42$.
70. One may have a pause here and take note that value 42 accepts organization as $42 = 21+21$ and value 21 accepts organization as $21 = 1+2+3+4+5+6$ which is parallel to self referral (1, 2, 3, 4, 5, 6) of the format and features of Sathapatya measuring rod synthesized by hyper cubes 1 to 6 of values and virtues of format of swapping of self referral domain of Surya (Sun), a real 6-space body.
71. One shall sit comfortably and to permit the transcending mind to continuously remain in prolonged sitting trans and to glimpse and imbibe the above values and features of Vedic systems attainment of the order of (क्षेत्रं क्षेत्रज्ञ तत्त्वज्ञान).

7. One may have a pause here and to permit the transcending mind to glimpse and imbibe these values and features.
8. Text of Ashtadhiyai is composed as sutras.

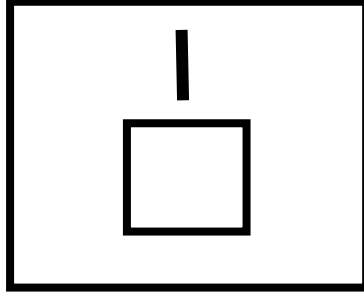

One may have a pause here and take note that to permit the transcending mind to continuously remain in prolonged sitting of trans and to glimpse and imbibe above values and features and to completely comprehend and to fully imbibe as that lord Brahma is the over lord of real 4-space which of a spatial order and format and feature of idol of lord Brahma are parallel to format and features of hyper cube 4 which is a four folds manifestation layer (2, 3, 4, 5) of summation value $2+3+4+5 = 14$ and hyper cube 14 is of 29 versions.
29. One shall further sit comfortably and to permit the transcending mind to glimpse and imbibe the distinct set ups of interval and square as representative regular bodies of 1-space and 2-space



30. And further as that, interval and square also manifests within a square.



31. It is this feature of independent but sequential existence of interval and square, also having simultaneous existence as a interval and square within a square, which deserves to be comprehended well.
32. One may have a pause here and take note that interval being the format of sutra-1.
33. Square is the format of sutra-2.
34. Interval and square within a square format of sutra-3.
35. One shall sit comfortably and to permit the transcending mind to glimpse and fully imbibe these values and features of format of sutras 1, 2 and 3 of Ashtadhiyai.
36. One may have a pause here and take note that sutars are of six different types.
37. First type of sutras are the sangya sutras with formulation Sangya being if transcendental code value 25.
38. Second type of sutras are pribasha sutras and formulation Pribasha is of transcendental code value 29.

39. One may have a pause here and take note that pair of values (25, 29) and the end pair of values are the transcendence range (25, 26, 27, 28, 29).
40. Value 25 is parallel to the transcendental code values of formulations Vishnu (विष्णु), Prithivi (पृथ्वी), Bhumi (भूमि), Bhuma (भूमा), Budhi (बुद्धि) and Dukha (दुःख).
41. The summation value of values of transcendence range 25, 26, 27, 28, 29 is $25+26+27+28+29 = 135$.
42. Value 135 accepts organization as $135 = 5 \times 27 = 5 \times 3^3$ which is parallel to the set up of five half dimensions of three dimensional frame of value 27 each.
43. One shall sit comfortably and to permit the transcending mind to glimpse and imbibe these values and features.
44. It would further be blissful to visit and revisit which avails 135 (1, 3, 5) parallel to 5-space domain is of solid dimensional frame and linear dimensions of dimensions.
45. The summation value $1+3+5 = 9$ and product value $1 \times 3 \times 5 = 15$, brings us face to face with formulation swara which accepts transcendental code value 15 and there are 9 swaras.

DOMAINS 1 TO 9

1. Domains 1 to 9 are the domains fold of hyper cubes 1 to 9.
2. Hyper cubes 1 to 9 are four folds manifestation layer : $(-1, 0, 1, 2)$, $(0, 1, 2, 3)$, $(1, 2, 3, 4)$, $(2, 3, 4, 5)$, $(3, 4, 5, 6)$, $(4, 5, 6, 7)$, $(5, 6, 7, 8)$, $(7, 8, 9, 10)$.
3. These four folds manifestation layer have $(-1, 0, 1, 2, 3, 4, 5, 6)$ as their respective dimension fold.
4. $(0, 1, 2, 3, 4, 5, 6, 7, 8)$ are the boundary folds.
5. $(1, 2, 3, 4, 5, 6, 7, 8, 9)$ are the domains fold.
6. $(2, 3, 4, 5, 6, 7, 8, 9, 10)$ are the origin fold.
7. Origin folds are within domain folds and are of placement at centre of the domains fold.
8. Centre of the domain fold is a dual status, firstly as constituent of domain space, and secondly as of next higher dimensional space of role of origin.
9. This leads to values $(1+2 = 3)$, $(2+3 = 5)$, $(3+4 = 7)$, $(4+5 = 9)$, $(5+6 = 11)$, $(6+7 = 13)$, $(7+8 = 15)$, $(8+9 = 17)$ and $(9+10 = 19)$ as values of domains with origins are 1-space to 9-space with 2-space to 10-space as origins.
10. One may have a pause here and take note that values 3, 5, 7, 9, 11, 13, 15, 17, 19 are parallel to respective geometric ranges of 1-space to 9-space.
11. These values are also parallel to respective versions of hyper cubes 1 to 9.

12. One may have a pause here and take note that with transcendence of origin from the domain folds the same leads to transcendence format of triple values in respect of these 1 domain to 9-space.
13. These transcendence triples are of values (1, 2, 1) (2, 3, 2), (3, 4, 3), (4, 5, 4), (5, 6, 5), (6, 7, 6), (7, 8, 7), (8, 9, 8), (9, 10, 9).
14. One may have a pause here and take note that these triples lead to summation values (4, 7, 10, 13, 16, 19, 22, 25, 28).
15. One may further have a pause here and take note that beginning with value 4 having reach at value 28 is a 7 steps long reach up-till value 28 which is parallel to transcendental code value 28 of formulation Braham.
16. One may further have a pause here and take note that each of these triple values spectra of these 9 domains results into a split of two parts each:
 $\{1, 2\}, \{2, 1\}, \{2, 3\}, \{3, 2\}, \{3, 4\}, \{4, 3\}, \{4, 5\}, \{5, 4\}, \{5, 6\}, \{6, 5\}, \{6, 7\}, \{7, 6\}, \{7, 8\}, \{8, 7\}, \{8, 9\}, \{9, 8\}, \{9, 10\}, \{10, 9\}$.
17. One may have a pause here and take note that spit of each of above 9 domain spectra into a pair of parts, as such, is of reflection pairs organization like (1, 2) and (2, 1).
18. This at first instance leads us to values pairs (3, -3), (5, -5), (7, -7), (9, -9), (11, -11), (13, -13), (15, -15), (17, -17), (19, -19).
19. One may have a pause here and take note that values pairs (3, -3) is parallel to a split of 3 dimensional frame of linear order into a pair of 3 dimensional frame of half linear dimension of opposite orientations.

20. Likewise, is the split of dimensional frame of 5, 7, 9, 11, 13, 15, 17 and 19 dimensional frame.
21. One shall sit comfortably and to permit the transcending mind to continuously remain in prolonged sitting of trans to glimpse and imbibe above values of domains 1 to 9.
22. One may have a pause here and take note that domain is the space content manifested as domain fold of respective hyper cubes as representative regular body of respective space.
23. The domain fold, as such plays its difference roles of which the first role is as of dimension fold.
24. The domain of 1-space plays the role of dimension of 3-space.
25. Likewise the domain fold of 7-space plays the role of dimension of 9-space.
26. One shall sit comfortably and to permit the transcending mind to glimpse and imbibe these values and features.
27. Further one shall glimpse 9 gaps of ten points range making ten points together with 9 gaps set ups as a value $10+9 = 19$.
28. N points with N-1 gaps make a set up of $2N-1$ value for values of $N = 1$ to 9.
29. One shall glimpse and imbibe these set ups of values 1 to 19.
30. One may have a pause here and take note that value $1 = 2x0+1$ brings us face to face with the set up of a pair of point and gap in-between as of value '1'.
31. It is here where one shall go for re-visit and to permit the transcending mind to continuously remain in prolonged sitting of trans and to glimpse and imbibe the zero space with 1-space as origin.

32. It would be blissful to visit the set up of interval as a set up of points of 1-space with 0-space points as its gaps.
33. It is this dual status for 0-space domain and 1-space domain in the same set up with deserves to be comprehended well.
34. One shall sit comfortably and to permit the transcending mind to glimpse and imbibe these values and features fully glimpse and to imbibe them completely to acquire proper insight and to attain appropriate enlightenment about such set ups.

Here it would be relevant to take note that second anthsatha

letter (ॠ) / Raif) is of three sequential evaluation phases (ॠ, ॡ, ॢ) accepting transcendental code values triple (1, 2, 3).

(iii) Letter (ॢ)

Third vowel (ॢ) of transcendental code value (3).

(iv and v) letter (ॣ, ।)

Fourth varga row letter (ॣ) accepting transcendental code value (4). Here it would be relevant to take note that parallel to value 4 is format of 4-space, which is of a spatial order. Here it also would be relevant to take note that fifth letter of formulation (श्रुतिः) Shrutī is second vowel (।) is of transcendental code value 2. Further it also would be relevant to take note that quadruple values (1, 2, 3, 4) as such accept factors (1, 2, 3, 2x2), which make of value (5). Still further it also will be relevant to take note that 2-space is of 5 geometries range and hyper cube 2, the representative regular body of 2-space in 4-space is of 5 versions.

(vi) letter (ः)

Fifth Yame letter (ः) accepts transcendental code value (13). Here it would be relevant to take note that numbers (1, 2, 3, 4, 5) accepts factors (1, 2, 3, 2x2, 5), which makes total factors being 6.

4. One may have a pause here and to sit comfortably and to permit the transcending mind to continuously remain in prolonged sitting of trans and to fully glimpse and imbibe above values and features of the organization of the composition of formulation (श्रुति) Shrutu as of six steps availing first Ushamana letter, second anthsatha letter, third vowel, forth varga consonant together with second vowel and fifth yama letters.
5. Formulation (श्रुति) is a composition of 5 letters of transcendental code value range (2, 1, 3, 4, 2) of summation value $2+1+3+4+2 = 12$.
6. One may have a pause here and take note that value 12 is parallel to the transcendental boundary (5-space boundary) of twelve Components of the self referral domain (6-space domain).
7. It would further be relevant to take note that self referral domain 6-space domain is of 13 versions of making representative regular body of 13 geometry of 6-space.
8. It would further be relevant to take note that range of 13 points has 12 gaps.
9. The set up of 13 points together with 12 gaps makes a set up of $13+12 = 25$ values set up.
10. One may further have a pause here and take note that value 25 accepts organization as $25 = 5 \times 5$.
11. It would be blissful to take note that transcendental boundary of 12 Components of self referral domain with its split and organization as $12 = 5+7$ brings us face to face with the

emerging format (5, 7) as parallel to the format of (5-space dimension, 7-space domain).

12. It further bring us face to face with the set up of 5x7 grid which accommodate all the 35 double digit numbers of 6 place value system

18. One may have a pause here and take note that 7 points range has 6 gaps and the set up of 7 points together with 6-space makes a set up number value 13 parallel to 13 geometries range of 6-space with their representative regular bodies being format and features of 13 versions of hyper cube 6.
19. A reach from 6-space domain to 7-space domain is a reach of the format and feature of the set up of hyper cube 7 as 7-space domain enveloped within self referral boundary (6-space boundary) of 14 Components.
20. Here it would be blissful to take note that formulation (सप्त) / sapt, seven) is (14).
21. It would further be blissful to take note that of 14 anubandhas (अनुबन्धः) of 14 Maheshwara sutras (महेश्वरः सूत्राङ्ग) are being only 13 of them being the distinct anubandh and the first anubandh repeating itself as the anubandh.

22. One shall sit comfortably and to permit the transcending mind to continuously remain in prolonged sitting of trans to glimpse and imbibe the above organization values and features to acquire proper insight and to attain appropriate enlightenment about organization format of Vedic knowledge and Vedic Samhitas.

26. The first string (2, 1, 3) as such is the re-organization of triple value (1, 2, 3) such that the first phase value (1) gets placement at the middle.

27. Likewise, the second string (3, 4, 2), as well is re-organization of (4, 3, 2) which for its value (4) settles the placement at the middle.

28. It is this organization feature which deserves to be comprehended well for its complete imbibe and full appreciation for the fixation of the middle as of 3rd step, with first step as fixation of first end point and second step being the fixation of second end point and it is there after at third step is going to be the fixation of the middle placement of settled pair of end points.

29. Let us have a pause here and pause to our self as to need and justification for quadruple value (1, 2, 3, 4) to have extension as (1, 2, 3, 4, 2), as the end reach for linear order value (1) up-till its reach at value 4 (as 4-space of spatial order) and hence fourth there being the play of spatial order.

30. Further, the value 1, 2, 3, 4, 2, making it as (2, 1, 3, 4, 2). And then, as (2, 1, 3, 2, 4) as is the end composition form of formulation Shruti where in second vowel (ऌ) gets placement

not as the end placement but the placement prior to the end placement of the only consonant (ॠ) of this composition.

31. This inward reach and the inward progression from linear order to spatial order with origin getting placement with in the domain is the organization format of Vedic system which make them of simultaneous outward and inward expansion.
32. It is this simultaneous inward and outward expansion which makes Vedic systems of unique potentiality.
33. One shall sit comfortably and to permit the transcending mind to revisit the set up of cube (as hyper cube 3 with 2-space in the role of boundary as well as in the role of spatial order of creative origin of hyper cube 3 as a four folds manifestation layer (1, 2, 3, 4).
34. Sadhakas fulfilled with intensity of urge to glimpse further and to imbibe further shall visit and revisit the set up of a 3 dimensional frame and the split phenomenon of a 3 dimensional frame into a pair of 3 dimensional frames of half dimensions.
35. One shall further glimpse and imbibe the features of synthesis of a three dimensional frame has of a pair of three dimensional frame of half dimensions.
36. It would further be blissful to glimpse and imbibe the values and features of the setup of a cube with a 3 dimensional frame of half dimensions imbedded in each of its eight corner points with inward orientation for all the dimensions of all the eight dimensional frames imbedded within eight corner points.

37. Further one shall glimpse and imbibe the organization format features of coordination of eight corner points of the cube as origin points of the respective three dimensional frames in terms of four internal diagonal of the cube passing through the centre of the cube.
38. Further one shall glimpse and imbibe diagonal as the translation path of the respective pair of 3 dimensional frame of half dimensions embedded in the corner points of the cube as end corner points of the respective diagonals
39. Further one shall glimpse and imbibe the phenomenon of a pair of three dimensional frame of half dimensions translating ahead from the corner points for their reach at the centre of the cube as middle point of the respective diagonal as translation path
40. Further, one shall glimpse and imbibe the unification and synthesis of the pair of three dimensional frame of half dimensions as a three dimensional frame of full dimension with centre of the cube as that origin of the 3 dimensional frame.
41. Further one shall glimpse and imbibe the centre of the cube as a seat of origin of 3 space and a seat of hyper cube 4, the representative regular body of 4-space as 4-space domain enveloped with solid boundary of 8 Component comprehends of the format and features of 8 octaves of 3-space and 8 sub cube of the cube.
42. Further one shall glimpse and imbibe centre of the cube as origin of 4-space as a seat of compactified origin of whole range of origins of whole range of hyper cubes as

- representative regular bodies of four and higher dimensional spaces.
43. It would be blissful to glimpse and reach at origin of 4-space compactified with origin of 3-space at centre of the cube itself.
 44. One shall sit comfortably and to permit the transcending mind to glimpse quadruple synthesized three dimensional frame together with the fifth 3 dimensional frame of cube with origin at the centre and they together making a solid dimensional frame of five solid dimensions of transcendental domain (5-space domain).
 45. The split of three dimensional frame into a pair of three dimensional frame of half dimensions with 4-space playing the role of common origin will bring us face to face with the format of values triple (3, 4, 3) as the format for with the format of processing format of value $3+4+3 = 10$ which as a dimension lead us to value 12 as domain and same is parallel to the transcendental code value of formulation (Shruti).
 46. One shall sit comfortably and to permit the transcending mind to glimpse and imbibe the value formulation shruti
 47. One shall sit comfortably and to permit the transcending mind to continuously remain in prolonged sitting of trans and to be face to face with formulation Rishi (ऋषि) which also is transcendental code value 12.
 48. It would be blissful exercise to tabulate formulation transcendental code value 12

51. Value $2^{11} = 2048 = 2024+24$ is parallel to 2024 vargas organization of the text of 432000 Akshras of Shakala Rig Ved Samhita and value 24 is parallel to 24 double digit numbers of 5 place value systems accepting format of 4x6 grid with 25 has Anubandh of this set up.
52. It would be blissful to take note that $25 = 2 \times 12 + 1$ Parallel to 25 geometries range of hyper cube 12 with 25 versions of hyper cube 12 as the representative regular bodies of 25 geometries of 25-space.

6. Formulation Dhrishta accepts transcendental code value (21).

 24. One may further have a pause here and take note that the transcendence from within origin of 3-space / centre of cube is of spatial order and its reach through 3-space domain is uptill spatial boundary of 6 Components.
 25. It is this reach and attainment uptill spatial boundary of 6 Components bring us face to face with the transcendental code value 6 of third ushmana letter (ष).
 26. One may have a pause here and take note that the script form of third ushmana letter (ष), as it is, of the format of a half rectangle.

27. One may have a pause here and take note that 3-space plays the role of origin of 2-space.
28. 3-space origin transcendence out of 2-space domain and as a result 2-space domain splits into two parts and as a result manifests transcendence format (2, 3, 2).
29. One may have a pause here and take note that, as a result cube representative regular body of (3-space in the role of origin of 2-space) splits into a pair of prisms.
30. One shall sit comfortably and to permit the transcending mind to continuously remain in prolonged sitting of trans and to glimpse split of cube into a pair of prism and at their middle being a release of 4-space of spatial order.
31. One may have a pause here and take note that 4-space is of 9 geometries range parallel to which manifest 9 versions of hyper cube 4 being representative regular body of 9 geometries and value 9 is parallel to transcendental code value 9 of fourth ushamana letters (६).
32. Sadhakas fulfilled with intensity of urge to acquire further insight and to attain further enlightenment shall permit the transcending mind to glimpse and acquire values and features of formulation Tarak Rishi (तर्क ऋषि) and Tattav Gyan (तत्त्व ज्ञान).

40. One shall sit comfortably and to permit the transcending mind to glimpse and imbibe above values and features to acquire proper insight and to attain appropriate enlightenment about Vedic formulations Dhristha (दृष्टा), Rishi (ऋषि), Tarak (), Tattav (तत्त्व) and Gyan (ज्ञान) by properly glimpsing and imbibing the value and formats of Ushamana letters.

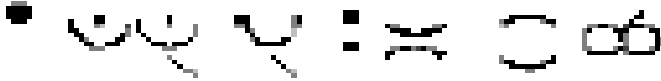

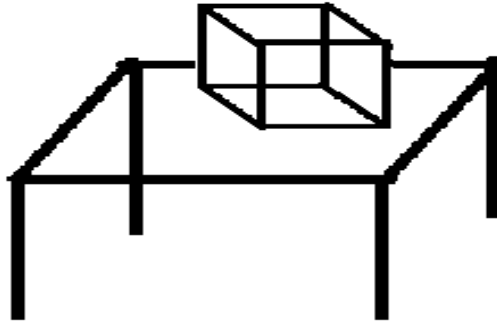

8. One may have a pause here and to permit the transcending mind to continuously remain in prolonged sitting of trans to glimpse and imbibe values and virtues of vedic knowledge as devnagri alphabet being its initiation as well as the ultimate attainment.
 9. Devnagri alphabet as the initiation, as well as the ultimate attainment, as the first virtue of Vedic system, further bring us face to face with the feature and value of organization of devnagri alphabet letters in a sequential frame of the format of cyclic set up of the circumference.
 10. One may have a pause here and to permit the transcending mind to glimpse and imbibe the set ups and format of circumference as a set up for accommodating the set up of a line superimposed for its transition and transformation as a set up of a circumference.

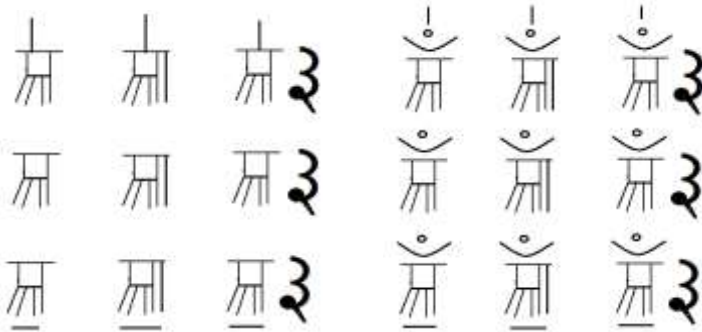
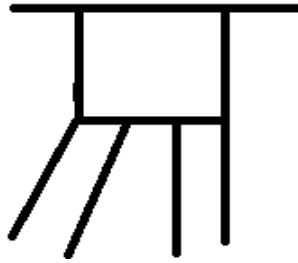
- of the transcendental domain (5-space domain) within a solid dimensional (3-space as dimension) frame of 5 dimensions.

33. It is (गुण) Guna / structural features.
34. It is (अकारा) Akara/
35. One may have a pause here and take note that TCV (वर्ण) = 18, TCV (स्वरा) = 15, TCV (अक्षर) = 13 and TCV (गुण) = 14, TCV (अकारा) = 8
36. It would further be blissful to take note that script form of letter (अ) is of the format and feature of cube placed upon

four legged table parallel to solid boundary Component of 4-space.



37. It would further be blissful to visit and revisit 18 formulations expressions of first of letter (37).



38. Sadhakas fulfilled with intensity of urge to glimpse and imbibe the vedic processing systems coordination of different letters being availed for formation of words composition shall also glimpse through the formulation expression and script form of other letter of devnagri alphabet as well.
39. Further, one shall also glimpse and imbibe the values and features of devnagri alphabet and way its letters are coordinated as per their placement within the alphabet and the way, as per the placement, letters acquire values.
40. Further, one shall also reach at the parallel geometric format for the respective value of the individual letters.

45. Sadhakas fulfilled with intensity of urge to acquire proper insight and to attain appropriate enlightenment about vedic systems as composed text availing devnagri alphabet format shall fully glimpse and to completely imbibe the value and features of Sathapatya measuring rod synthesized by hyper cubes 1 to 9 as representative regular body of 1 to 9-space.

23. One shall further glimpse and imbibe the format and values of 120, which accepts 15 divisors (1, 2, 3, 4, 5, 6, 8, 10, 12, 15, 20, 24, 30, 60, 120).
24. It would be blissful to take note that TCV Panch = 15.
25.
