**SHIV PURAN  
Vidyeshvara Samhita**

**Chapter – 2**

=====

1. Having transcendental (5-space) feel of the urge of *Munigan* मुनिगन, *Suta* सुत showed gratitude to them and said that they have urge to know for the welfare of everybody about the transcendental (5-space) values.
2. *Suta* सुत expressed that these values are of Shiv Puran which is of the order of Vedanta (essence of Vedas).
3. *Suta* सुत, then conveyed that this (Shiv Puran) which is of the order of Vedas, was originally unfolded by Lord Shiv Himself as a scripture of 12 Samhitas संहिता, namely
  - (i) विदेश्वर संहिता Vidyeshvara Samhita of 10000 shalokas
  - (ii) रुद्र संहिता Rudra Samhita of 8000 shalokas
  - (iii) विनायक संहिता Vinayak Samhita of 8000 shalokas

- (iv) उमा संहिता Uma Samhita of 8000 shalokas
  - (v) मैत्री संहिता Matriya Samhita of 8000 shalokas
  - (vi) एकदश रुद्र संहिता Ekadash Rudra Samhita of 13000 shalokas
  - (vii) कैलाश संहिता Kailash Samhita of 6000 shalokas
  - (viii) सतरुद्र संहिता Satrudra Samhita of 3000 shalokas
  - (ix) कोटि रुद्र संहिता Kotirudra samhita of 9000 shalokas
  - (x) संहस्त्रकोटि संहिता Saheshtrakoti samhita of 11000 shalokas,
  - (xi) वायव्य संहिता Vayaviya Samhita of 4000 shalokas Vayaviya
  - (xii) धर्म संहिता Dharam Samhita of 12000 shalokas
4. This range of knowledge of Shiv Puran unfolded by lord Shiv was re-organized by व्यास ऋषि Vyas Rishi as a scripture of 7 samhitas of total 24000 shalokas.
  5. The सूत Suta further informed munigan that the whole range of knowledge domain of Purans was originally unfolded as single wholesome Puran of 100 crores ( $10^9$ ) shalokas.
  6. Ved Vyas Rishi had re-organized values of this range of knowledge as 18 Purans of total range of 4 lacs ( $4 \times 10^5$ ) shalokas.
  7. Of these 18 Purans range, Shiv puran is of fourth placement.
  8. This fourth placement Shiv Puran is of 7 samhitas of 24000 shalokas range.
  9. The seven Samhitas of this re-organized Shiv Puran of its fourth placement of 18 Purans range is a scripture of 7 Samhitas namely
    - (i) Vidyesvara Samhita (ii) Rudra Samhita (iii) Satrudra Samhita (iv) Kotirudra Samhita (v) Uma Samhita (vi) Kailash Samhita (vii) Vayaviya Samhita
  10. Here it may be relevant to note that Yaviya Samhita in its first chapter gives the names of 18 Purans as
    - (i) Brahma Puran ब्रह्म पुराण (ii) Padama Puran पदम् पुराण (iii) Vishnu Puran विष्णु पुराण (iv) Shiva Puran शिव पुराण (V) Bhagavata Puran भागवत पुराण (vi) Bhavishya Puran भविष्य पुराण (vii) Narada Puran नारद पुराण (viii) Markandeya Puran मारकेण्डय पुराण (ix) Agni Puran अग्नि पुराण (X) Brahma Vaivarta Purāṇam ब्रह्म वेवर्त पुराण (xi) Linga Puran लिंगं पुराण (xii) Varāha Purāṇam वराह पुराण (xiii) Skanda Purāṇam स्कन्द पुराण (xiv) Vāmana Purāṇam वामन पुराण (xv) Kūrma Purāṇam कर्म पुराण (xvi) Matsya Purāṇam मतस्य पुराण (xvii) Garuda Purāṇam गरुड पुराण (xviii) Brahmāṇḍa Purāṇam ब्रह्मन्न्द पुराण
  11. Shalokas range of 7 Samhitas of Shiv Puran of above fourth placement is mentioned in the Yvaviya Samhita in its first chapter as:
    - (i) Vidyesvara Samhita (of 2000 shalokas range)
    - (ii) Rudra Samhita (of 10500 shalokas range)
    - (iii) Satrudra Samhita (of 2180 shalokas range)

- (iv) Kotirudra Samhita (of 2240 shalokas range)
  - (v) Uma Samhita (of 1840 shalokas range)
  - (vi) Kailash Samhita (of 1240 shalokas range)
  - (vii) Vayaviya Samhita (of 4000 shalokas range)
12. Here further would be relevant to note that the Shiv Puran Text which has reached us as Rudra Samhita (second Samhita of five parts) namely Srishti Khand (ii) Sati Khand (iii) Parvati Khand (iv) Kumar Khand (v) Yudh Khand
13. Further as that the Yvaviya Samhi (7000) text of two parts Vayaviya Purva Khand and Yvaviya Samhita Utter Khand.
14. This way our chase of transcendental (5-space) domains knowledge in terms of the Shiv Puran which has reach in the background of above organization features.

2. This project is for settlement of text books of Vedic Mathematics for classes eight to twelfth.
3. Text book for each class would be of three parts
  - Part – 1 ‘Vedic Mathematics for class VIII  
(likewise for class 9, class 10, class 11 and class 12)
  - Part – 2 ‘Vedic Mathematics exercises for class VIII’  
(likewise for class 9, class 10, class 11 and class 12)
  - Part – 3 ‘Teaching and evaluation manual of Vedic Mathematics for class VIII’  
(likewise for class 9, class 10, class 11 and class 12)
4. Each sutra and Upsutra would be taken up in separate section exclusively devoted to particular Sutra / Upsutra.
5. This way in all, there would be 29 sections for coverage of all the sixteen Sutras and 13 Upsutras.

6. Participants may contribute for all the 29 sections but each Sutra and Upsutra shall be taken up as independent aspect of values of mathematics as every Sutra values are to be covered in distinct section.
7. The intellectual contribution of participants shall be duly recognized and same shall be properly respected.
8. In the light of this theme, we shall be making separate requests for each sutra and upsutra.
